Republic Services' Tania Ragland-Castaneda's Community Commitment to Sustainability

Tania Ragland-Castaneda currently serves as the Municipal Relationship Manager and national spokesperson for Republic Services. Republic Services has been the waste removal servicer for the City of Rosemead for over 25 years. The Rosemead Report spoke with Tania to discuss her various roles and what that means for the benefit of the community and how her work helps to shape programs in the industry and the potential to influence local and national legislation.

Castaneda has always had an interest in the waste disposal industry since she began her educational career at Santa Monica College.

"[SMC] had a Recycling Resource Management program that was funded by the state and they had such success with it that the school decided to continue it after the funding ended."

Castaneda said. "In that program I learned everything pertaining to the waste industry and recycling, and it really prepared me for a career."

Castaneda continued her education at Arizona State University where she earned the respect of her future employers through her extensive knowledge of the industry and the numerous regulations encompassing it.

Castaneda has always taken environmentalism seriously and her roles with Republic Services have proven that—first as a Recycling Coordinator and then as an Organics Program Manager and then promoted last year into the role of Municipal Relationship Manager.

"In my career at Republic Services, I started out as Recycling Coordinator, really working with a variety of customers across L.A. County to get them on a good sustainability program—to get them on a recycling program or a food waste recycling program," said Castaneda. "A lot of these programs are driven by legislation, so not only do they have to participate, because in many cases they are required to by law, but many times they also have the values of wanting to improve on their programs."

In response, Castaneda piloted a food recovery program in select cities where she was working.

"This was kind of ahead of the trend...ahead of the curve of thinking of food in terms of 'can this be given to people instead of composted or disposed of?'" Castaneda said.

Castaneda emphasized the significant amount of food waste every year. She said that sometimes manufacturers or suppliers may throw out large amounts of food that is still consumable due to defects in appearance or packaging issues.

"Organics became such a bigger topic and so they hired me to initiate a county-wide program with our Republic Services customers so that we can work on a broader scale and scale-up that initial pilot program," Castaneda said. "It

was a success working with hundreds of our customers across L.A. County as Organics Program Manager."

Castaneda went to several facilities and helped to design compost programs, coordinate meetings with food banks, and educated customers on the options available to them for distributing their food to people or through more sustainable means of waste disposal such as composting. Castaneda said that within about 2 years of her initiatives and outreach, she helped recover over 1 million pounds of food and directed it to local food banks by educating businesses on what the available alternatives.

In her latest role as Municipal Relationship Manager, she continues her previous duties plus more, but with a shift toward a focus mostly on the government sector. The focus on sustainability has shifted from a customer level (such as businesses like baseball parks and grocery stores) to entire communities and municipalities.

"That's what's really exciting...that all of my knowledge and experience transitions now to help our elected officials to have a community-wide program," Castaneda said. "It has been very exciting for me to work with a different type of clientele, and serve councilmembers and our government elected officials because they have the opportunity to really be 'change agents' and allow for programs and funding and possibilities, and so it has been a great step for me, because we can continue to do really good work at a higher level."

When asked about the potential to help generate new legislation, Castaneda said:

"We get called upon quite frequently by legislators asking for knowledge or experience, so we work with state regulators such as CalRecycle and there's been times when they've come to us here locally and we've done presentations for them and given them some case studies that has really helped craft some of the stuff 'up north,' so while we're not necessarily directly writing policy, we help provide insight to potential policies."

Castaneda was recognized for her achievements by earning the Waste360 40 Under 40 award in 2019. According to the website, 'Awards are presented by Waste360 to recognize and reward the rising stars and young professionals within the industry.'

"It's really fascinating because I really do believe that we were ahead of the conversation and we were able to work with customers in a very unique way that ended up being...now we see a lot of different types of waste haulers or waste consultants start to engage in [it]."

Castaneda said. "We really help set the precedents and pioneered a program and it's being evaluated now nationally, so it gives people the opportunity (on a national level) to really learn what we're doing here in Los Angeles County and how we're collaborating with food banks, with businesses, and with elected officials."

Castaneda explained that organic material takes up more than 30 percent of what's going into a landfill—millions and millions of tons.

"It doesn't disintegrate the way people think it does," Castaneda said. "Instead, it is buried like how you put something in a Tupperware and it off-gases and that gas is methane and it's essentially air pollution—air emissions. So, you have a valuable resource that could be feeding people or that could be nourishing our soils and that's what we're trying to do on a larger scale."

She has also helped to create educational videos on the topic of recycling. In addition to her regular job duties, she also serves as the national spokesperson for Republic Services. Castaneda represents the company through news segments, online media, filmed projects, and corporate initiatives.

"Videos are a great medium to help educate people, especially now with everyone being virtual and on social media," Castaneda said. "For these videos, we're launching a national Recycling Simplified campaign to help people understand the best practices in recycling, because contamination is a huge problem in our industry."

Castaneda explained that China has essentially stopped purchasing United States recyclables because it is so contaminated by trash, liquid, and soils. Republic Services has taken a national approach to educating consumers on the best way to become good recyclers so that the recyclable materials collected can actually be recycled through the prevention of contamination.

"Rosemead is an incredible community," Castaneda said. "The elected officials are passionate and engaged and are committed to bringing resources to the city. The staff is always wonderful in partnering with us. We strive in being an active and dedicated partner and that means bringing our resources—not just funding, but our time, our ideas, and our relationships that we have to the community."

Castaneda is on the advisory board for Waste Not Our Communities. The website states that they are a public-private partnership formed with the goal of eliminating hunger and reducing food waste by facilitating the donation of wholesome surplus food from permitted food facilities to local pantries.

"They do such incredible work in food recovery and working with restaurants to make sure that food is not wasted and helping create meals from anything that's collected and distributed to people," Castaneda said. "Through that relationship, we were able to bring [Waste Not OC] in and they helped us a lot in planning—they helped [me] and the City Manager."

"We collaborated as a team to bring forth more of these opportunities—more of these food drive events to the city and it's really

Seniors Missing Savings Deadline

Replacement dwelling must be bought within 2 years

The Senior Replacement Home Program (also known as Prop 60/90) was featured in last month's newsletter and is a valuable program that allows a homeowner who is 55 years or older to move and take their lower property tax-base with them.

However, when the original home is sold, you have two years to purchase the replacement. The issue is that with COVID-19 some have put off purchasing the replacement property and have missed the two-year deadline and are therefore not eligible to take advantage of this tax-savings' program.

For example, if you sold your home in May 2018 with the intention of using a Prop 60/90 transfer, you would have had until May 2020 to purchase the replacement property to be able to use the Replacement Home Program.

Please note this is not intended to constitute legal and financial advice, but to make taxpayers aware of this potential complication in the current context.

Who Qualifies?

1. The replacement property must be your principal residence and must be eligible for the Homeowners' Exemption or Disabled Veterans' Exemption.

2. The replacement property must be of equal or lesser "current market value" than the original property. The "equal or lesser" test is applied to the entire replacement residence, even if the owner of the original property acquires only a partial interest in the replacement residence. Owners of

two qualifying original residences may not combine the values of those properties in order to qualify for a Proposition 60 base-year transfer to a replacement residence of greater value than the more valuable of the two original residences.

3. The replacement property must be purchased or built within two years (before or after) of the sale of the original property.

4. Your original property must have been eligible for the Homeowners' or Disabled Veterans' Exemption.

5. You, or a spouse residing with you, must have been at least 55 years of age when the original property was sold.

6. If you or your spouse who resides with you is age 55 or older, you may buy or construct a new home of equal or lesser value than your existing home and transfer the trended base value to your new property.

7. This is a one-time only benefit. You must buy or complete construction of your replacement home within two years of the sale of the original property. Both the original home and the new home must be your principal place of residence. A claim must be filed within three years of purchasing or completing new construction of the replacement property. If a claim is filed after the three-year period, relief will be granted beginning with the calendar year in which the claim was filed.

8. Once you have filed and received this tax relief, neither you nor your spouse who resides with you can ever file again.

"We love the community. We have been the service provider for over 25 years. Our drivers live in the community as well—in the very community that they serve. We take great pride in keeping the community clean and being the best partner that we can be."



Dear Friends / Queridos Amigo

With the \$1.22 billion CARES Act funding Los Angeles County is set to receive from Congress, the Board of Supervisors on Tuesday boldly demonstrated a commitment to prioritize funding to low-income communities of color.

To that end, I was pleased that our spending plan adopted many of the allocations I championed early on, including:

- \$301 million for COVID-19 testing and contact tracing;
- \$100 million for rent relief, which includes eviction defense and expands on the efforts of a motion I had co-authored with Supervisor Hahn
- \$160 million for grants to small businesses and help employers comply with worker protection requirements, stemming from my motion on June 9. This will ensure people who return to work are protected while on the job;
 - o Funding must be directed to small local businesses, mom-and-pop shops, especially in disadvantaged communities, and not to large corporations;
- This pandemic has ignited widespread hunger. \$85 million will be set aside for food assistance because no one in LA County should go hungry; and
- \$15 million for childcare prioritized for residents who are indigent essential workers.

More resources and assistance will be needed for our most vulnerable communities in the months to come. But spending down these CARES Act dollars will provide a measure of relief for our residents.

At the Board of Supervisors meeting on Tuesday, Supervisor Sheila Kuehl and I presented a motion to draft a ballot measure asking the voters to Re-imagine Los Angeles. If approved by the voters, the measure would set aside at least 10 percent of the County's unrestricted funds to invest in youth, community and workforce development programs, affordable housing, alternatives to incarceration, community-based health services, and more. We need these programs and services now more than ever. I am proud to receive the support of my colleagues through a 4 to 1 vote, and for the tireless advocacy by our community members.

Together, we will Re-Imagine LA County.

Con los \$1.22 billones de dólares que Congreso asignará al Condado de Los Ángeles, la Junta de Supervisores demostró el martes con audacia su compromiso de priorizar los fondos para las comunidades de color de bajos ingresos.

Con ese fin, me alegró que nuestro plan de gastos adoptó muchas de las asignaciones que defendí desde el principio, incluyendo:

- \$301 millones para las pruebas de COVID-19 y la localización de contactos;
- \$100 millones de dólares se han asignado para alivio de renta, que incluye la defensa del desalojo y ampliar los esfuerzos de una moción de que fui coautora con la supervisora Hahn
- Una asignación de \$160 millones de dólares para ofrecer subvenciones a pequeñas empresas y ayudar a los empleadores a cumplir con los requisitos de protección de los trabajadores, lo cual sale de mi moción del 9 de junio. Esto ayudará a asegurar que las personas que regresen al trabajo estén protegidas en el trabajo;
 - oLa financiación debe dirigirse a las pequeñas empresas locales, a las tiendas de mamá y papá, especialmente en las comunidades de bajos recursos, y no a las grandes corporaciones;
- Esta pandemia ha provocado un hambre amplio. Para ello, se han reservado \$85 millones de dólares para alimentos, porque nadie en el Condado de Los Ángeles debe pasar hambre; y
- \$15 millones de dólares para el cuidado de los niños priorizado para los residentes que son trabajadores esenciales indigentes.

Se necesitarán más recursos y asistencia para nuestras comunidades más vulnerables en los próximos meses. Pero gastar estos dólares de la Ley CARES ofrecerá una medida de alivio para nuestros residentes.

En la reunión de la Junta de Supervisores del martes, la Supervisora Sheila Kuehl y yo presentamos una moción para redactar una medida de votación pidiendo a los votantes a Reimaginar a Los Ángeles. Si los votantes la aprueban, la medida apartaría al menos el 10 percent de los fondos no restringidos del Condado para invertir en programas de desarrollo juvenil, comunitario y laboral, viviendas asequibles, alternativas al encarcelamiento, servicios de salud basados en la comunidad, y más. Necesitamos estos programas y servicios ahora más que nunca. Me enorgullece recibir el apoyo de mis colegas a través de una votación de 4 a 1, y por la incansable defensa de nuestros miembros de la comunidad.

Juntos, reimaginaremos el Condado de Los Ángeles.

The Joint: Frequently Asked Questions

- Q:** Are all patients given the same type care?
A: In actuality, there are three stages of chiropractic care:
- Relief**
If you are experiencing aches, pains and or decreased range of motion, our licensed chiropractors will work to identify the source of the issue and eliminate joint restrictions, also known as subluxations. Subluxations can get in the way of proper nerve communication from the brain to the body—often resulting in pain and discomfort. While seeking relief, your doctor may recommend multiple visits per week, for two to four weeks, or until the pain is reduced. Your doctor will likely also recommend home therapies such as icing and/or stretching at home.
- Recovery**

Dear Rosemead Community,

At a Special Board meeting held on July 14, 2020, our Board formally approved my recommendation that we begin the school year via Distance Learning only. As such, all Rosemead schools will start the school year via full Distance Learning. We know that news is disappointing for our community, but we must understand that the safety of our students and staff have to be our highest priority. We cannot ignore the current environment of anxiety and fear as we experience a significant rise of positive COVID-19 cases in all of Southern California. We must also attend to the fact that our state as a whole has rolled back reopening plans to include closing previously open non-essential businesses and offices in order to help stop the spread of COVID-19.

We are fortunate that our Reopening of Schools Task Force kept this possibility in mind as we developed an adaptable reopening of schools plan. The plan we presented to our district community included the possibility that we would have to return to school dismissal. Our district teams have already begun the development of a high quality Distance Learning program. We will also continue to work on our return to in class instruction in order to be prepared for a hybrid or full traditional program.

When we transitioned to school closure at the end of our last school year, our fantastic team of educators came together to ensure we offered our students the best academic program and support system possible. I have no doubt we will do this again, and do it better. I am also confident that we will be ready when we are able to welcome back students to in class instruction when it is deemed safe.

More information on our Distance Learning program for the new school year including student and parent orientation, student and parent expectations, technology support, and other topics, will be made available in the coming weeks. We will also continue to keep you updated as we receive more information and guidance from our county health and education officials.
